**AFFIDAVIT OF DEVI DASRAT IN OPPOSITION TO
PLAINTIFFS' MOTION FOR PARTIAL SUMMARY JUDGMENT**

Before me, the undersigned authority, personally appeared

DEVIWATTIE DASRAT, who upon being first duly sworn, deposes and says as follows:

1. I am over 18 years of age and have personal knowledge of the facts set forth in this Affidavit.

2. My name is DEVIWATTIE DASRAT, and at all times material hereto, I was a member of Bhuvaneshwar Mandir, Inc. ("Bhuvaneshwar"). I became a member of Bhuvaneshwar in September 2003. I was entitled to vote on actions of the Bhuvaneshwar when a member vote was necessary.

3. I examined the membership rosters that were submitted by Basdeo

Jagnandan as Exhibit “8” to the Partial Motion for Summary Judgment (the Membership Roster”). Although I dispute the accuracy and correctness of the Membership Roster, my name appears on same.

4. I am aware that Basdeo Jagnandan and Ramanand Rewah attempted to improperly hold an election for the appointment of new officers for Bhuvaneshwar.

5. In or around April 30, 2005, Basdeo Jagnandan and Ramanand Rewah allegedly presented a “Consent to Action of Members Without Meeting of BHUVANESHWAR MANDIR, INC., a Florida Nonprofit Corporation” for certain individuals listed on the Membership Roster to sign for the appointment of various directors of Bhuvaneshwar (the “First Consent”). I did not sign the First Consent nor did I receive notice that summarized the material features of the authorized action within ten (10) days of the purported authorization by written consent.

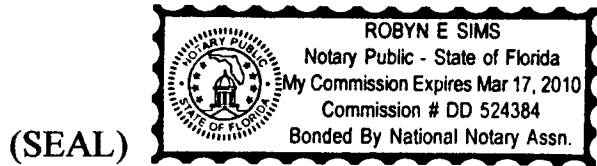

In or around May 22, 2005, Basdeo Jagnandan and Ramanand Rewah allegedly presented a second “Consent to Action of Members Without Meeting of BHUVANESHWAR MANDIR, INC., a Florida Nonprofit Corporation” for certain individuals listed on the Membership Roster to sign for the appointment of various directors of the Bhuvaneshwar, the approval of Articles of Amendment of the Bhuvaneshwar, the approval of amending the name of the Bhuvaneshwar, and the approval of amended bylaws (the “Second Consent”). I did not sign the


Second Consent nor did I receive notice that summarized the material features of the authorized action within ten (10) days of the purported authorization by written consent.
